

PROCEEDINGS OF O'BRIEN COUNTY SUPERVISORS

December 10, 2019

The Board of Supervisors met as per adjournment in regular session at 9:05 a.m. with all members present.

Moved by Friedrichsen, seconded by Vanden Hull to approve the proceedings of December 3, 2019. Motion carried by all ayes.

Moved by McDowell, seconded by Steensma to approve the following appointments effective December 1, 2019: Laura Scroggin, Motor Vehicle Deputy - \$85% of County Treasurer; Brooke Scroggin, Driver's License Deputy – 85% of County Treasurer; Angela Plagge, Motor Vehicle & Driver's License Clerk – 65% of County Treasurer. Motion carried by all ayes.

Moved by Vanden Hull to set a bounty on beaver as follows: December 16, 2019 thru January 30, 2020 - \$20 each; February 3 – 24, 2020 - \$30; March – April, 2020 - \$40 with a maximum bounty pay-out of \$10,000. Motion died for lack of second.

Moved by Friedrichsen, seconded by Steensma to implement a \$35.00 per beaver bounty effective with the beginning of beaver trapping season through one week after the end of the season to redeem the bounty with a maximum of \$5,000 for bounties paid out. Motion carried by all ayes.

Moved by Friedrichsen, seconded by Vanden Hull to join in the motion by Iowa Information to lift the stay on the 2018 Marcus News verses O'Brien County Board of Supervisors civil complaint and the Board reserves the right not to join the stay in the 2019 lifting of the stay. Motion carried by all ayes.

Moved by Friedrichsen, seconded by Vanden Hull to amend the previous motion to join in the motion by Iowa Information to lift the 2019 stay for the Marcus News verses O'Brien County Board of Supervisors civil complaint. Motion carried by all ayes.

The Board discussed the comment period for the proposed new FEMA Flood maps. The comment period for the Proposed Flood Hazard Determination ends on December 13, 2019. The Board has not received any comments.
