

PROCEEDINGS OF O'BRIEN COUNTY SUPERVISORS

June 9, 2020

The Board of Supervisors met as per adjournment in regular session at 9:00 a.m. with all members present. This meeting is being held electronically due to the COVID-19 pandemic and restrictions imposed on the number of people allowed to assemble.

Moved by Friedrichsen, seconded by Vanden Hull to approve the proceedings of June 2, 2020. Motion carried by all ayes.

At 9:05 a.m. in accordance with the Code of Iowa, the Board canvassed the Primary Election returns for O'Brien County and declared the following candidates nominated to be placed on the General Election ballot to be voted on November 3, 2020:

Moved by McDowell, seconded by Bootsma to approve the appointment of Trisha Odenbrett at a Part-time Food Service worker effective June 8, 2020 at \$15.14 per hour. Motion carried by all ayes.

Moved by Bootsma, seconded by Friedrichsen to approve the fireworks permit for Solsma's Punkin Patch. Motion carried by all ayes.

Moved by Friedrichsen, seconded by Vanden Hull to authorize the Chairman to sign a 3-year contact with Cost Advisory Service, Inc. for professional consulting services to the County. This contract will not exceed \$4,125 per year (current contract cost). Motion carried by all ayes.

Moved by McDowell, seconded by Bootsma to adopt Resolution 2020-18, a resolution to close the BETS Fund and pay the balance of \$1,318.30 to the County General fund. Motion carried by all ayes.
