

PROCEEDINGS OF O'BRIEN COUNTY SUPERVISORS

September 15, 2020

The Board of Supervisors met as per adjournment in regular session at 9:01 a.m. with all members present. Dennis Vanden Hull attended by phone. This meeting is being held electronically due to the COVID-19 pandemic and restrictions imposed on the number of people allowed to assemble.

Moved by Bootsma, seconded by Friedrichsen to approve the proceedings of September 8, 2020. Motion carried by all ayes.

Moved by Bootsma, seconded by Friedrichsen to increase the Medical Examiner fees to \$300 per hour effective September 15, 2020 and to continue with the \$35 cremation certificate fees. Motion carried by all ayes.

Moved by McDowell, seconded by Friedrichsen to opt out of the presidential directive to defer the payment of employee social security tax from September 1, 2020 – December 31, 2020. Under the deferment, these taxes would then be collected from January 1, 2021 through April 30, 2021. Motion carried by all ayes.

Moved by Friedrichsen, seconded by Vanden Hull to authorize the Chair to sign a gravel contract with Bruce and Carol Rohwer for 100,000 tons of gravel at \$.87 per ton for a total of \$87,000. Motion carried by all ayes.

Moved by Bootsma, seconded by Friedrichsen to approve the tile crossing applications of Keith Iversen in Sections 5 & 8, Dale Township. Motion carried by all ayes.

Moved by Friedrichsen, seconded by Bootsma to authorize the Chair to sign a Temporary Lyon-O'Brien County Attorney 28E Agreement for Lyon County to utilize the services of the O'Brien County Attorney or her assistant during the time that Lyon County is without a County Attorney. Motion carried by all ayes.
